Re: Precinct Boundaries for 2014

Dear Commissioners:

State law requires the county to have precinct boundaries & polling locations set before December 31st. At this time, all precinct boundaries will remain the same as established for 2012, with the exception of Legislative District 45.

We are proposing boundary changes to Legislative District 45 in the hopes of reducing some of the congestion on Election Day at the FargoDome. The changes we made will move those north of County Rd 20 to the polling location in Harwood, with the exception of the development between County Rd 31 and the Red River as they are in the City of Fargo. It makes more sense for them to continue voting at the FargoDome. The changes will also move those south of County Rd 20 and west of I29 into a new precinct. It is our plan at this time to designate the Reiles Acres Community Center as the polling location for that precinct.

I have included maps of Legislative District 45 showing the current precinct boundaries, and the legal descriptions of each precinct in that district.
