Dear Mr. Benson,

The ND Department of Emergency Services (NDDES) has been working closely with Cass County, the Lake Agassiz Regional Council, and FEMA to close the FMA 2009 Project 001 Cass County Acquisitions project. After a project is completed, all documentation must be submitted to FEMA so the project can be closed on the State and Federal levels. If additional information, documentation, or further actions are still required before the project can be closed, FEMA will send out a Request for Information (RFI) explaining what is still required.

For FMA Project 001, FEMA sent out an RFI on April 1, 2014 citing numerous issues which needed to be resolved before closeout, such as ineligible costs, missing environmental letters, and missing homeowner documentation. The NDDES has received numerous items from Cass County and the Lake Agassiz Regional Council to satisfy this RFI, but additional documentation is still required.

On June 28, 2014, the NDDES received an updated RFI for FMA Project 001 from FEMA. According to this RFI, FEMA has deemed that certain costs submitted for reimbursement through the NDDES are not eligible based upon information from the Unified Hazard Mitigation Assistance (HMA) Guidance and 2 CFR Part 225, and those costs need to be repaid before the project can be officially closed on the state and federal levels.

The costs FEMA have deemed as ineligible are included in the attached financial review document. Examples of ineligible costs include winter maintenance and electrical expenses on homes the county purchased and planned to auction, the removal and installation of trees to assist with the relocation of a home that had been sold at auction, and costs for the removal of HVAC items from a home that was not purchased as part of the final project. Additionally, there is also a small amount that still needed to be recouped for third appraisals which are not eligible for reimbursement. Some money has already been repaid for these third appraisals, but not enough to cover the Federal and State shares.

Jack Dalrymple Governor Greg M. Wilz Director - Division of Homeland Security Based on the documentation from FEMA, the amount of inelgiible expenses total \$36,957.11. Since all projects funded through FEMA HMA Programs are broken down by cost shares, the Federal and State shares are 85% of the ineligible expenses, or \$31,413.54. Additionally, there is a total of \$467 of Federal and State shares still required for the third appraisals mentioned aboved, which means the final amount that needs to be repaid to FEMA and the State is \$31,880.54.

Please remit payment to the NDDES in the amount of \$31,880.54 as soon as possible. If you would like to appeal this decision, please provide additional documentation explaining why these costs should be considered eligible to Paul Messner, State Hazard Mitigation Officer, no later than July 18, 2014. This information will be reviewed and forwarded to FEMA for additional consideration.
