Burn Ban Declaration

Commissioners:

- We are all aware of the extremely dry conditions. On April 5th, 2021, this commission enacted a burn ban to be activated based on the fire danger index map rating of Very High or Extreme and/or a Red Flag Warning issued by the National Weather Service.
- Recent conversations and requests from rural fire chiefs have indicated a need for a more restrictive ban due to number of service calls, fires within residential areas, and the upcoming harvest season.
- Two declarations are before you today both presenting the option of an increased or tightening of the burn ban.
 - Adding the fire danger index rating level of "High"
 - o Adding the fire danger index rating levels of both "High" and "Moderate"
- Based on the number of calls for service, the ongoing drought conditions, the drying of crops, I
 would suggest adoption of the declaration with the "Moderate" level or higher index rating to
 activate the burn ban.

Suggested Motion: Move to accept changes to our current burn ban declaration by adding both "Moderate" and "High" fire danger index ratings that activate the burn ban.
