

# **County ARPA Funding**

- The County Finance Office has identified \$5.5 million in ARPA funding available for Highway and Bridge Projects
- The Cass County Highway Department is requesting the Road Advisory Committee recommend the County Commission approve of \$5.5 million for Highway and Bridge Projects to be constructed in 2022 and 2023



# State ARPA Funding

- The ND Legislative Special Session may provide some additional State ARPA Funding
- Any State ARPA funds will help offset the loss of \$7.1 million in Prairie Dog funding in 2021-22 and reduced revenue from the State Highway Distribution Fund (\$700k-\$800k per year).
- If additional State ARPA Funding is available, the Cass County Highway Department will prepare additional projects to be constructed in 2022-23




# Federal Highway Funding

- Message from NDACo: Stay tuned, as some of this will be direct grants to counties, and we need to be ready to jump
- Office of the Secretary of Transportation (OST)
  - NEW: National Infrastructure Project Assistance Grants: \$15 billion
  - NEW: Safe Streets and Roads for All: \$6 billion
  - NEW: Office of Multimodal Freight Infrastructure (critical for supply chain issues)
  - NEW: Culvert removal, replacement and restoration \$1 billion
- Federal Highways Administration (FHWA)
  - \$351 billion for highways with \$307 billion provided through formula programs to states. (If NDDOT maintains the local sharing arrangement, this will increase all counties' amounts)
  - \$16 billion for the Highway Safety Improvement Program
  - National Significant Federal Lands Projects and Tribal Projects: \$1.5 billion
  - BRIDGES: Largest investment in bridges since the beginning of the interstate highway system with a new \$28 billion formula based FHWA Bridge program and a NEW \$16 billion bridge grant program.
  - NEW: Rural Surface Transportation Grant Program: \$2 billion







## **Davenport Shop Options**

#### **Davenport Shop**



- New 50'x50' shop complete. Cost approximately \$89 per S.F.
- Options for existing 40'x50' shop.
  - Private parties interested in buying.
  - KNDPA is also interested in purchasing the building for their respective township maintenance equipment.
- Bought 45'x48' cold storage on 0.45 acres for \$150,000 which is \$69.44 per S.F.
- KNDPA is asking us to sell existing 1982 40'x50' building on 0.11 acres for \$125,000 which is \$62.5 per S.F.

## **Office Remodel**

# **Highway Dept Office Remodel**

Challenges:

- 1. Last remodel was in 1997
- 2. Most cubicles, office furniture, and wall coverings/painting is from 1997
- 3. Carpet was last replaced in 2005
- 4. Office space is at over capacity

Opportunities:

- 1. COVID Funding
- 2. Complete a remodel rather than just updating cubicles, furniture, and painting
- 3. A remodel concept was developed in 2018 and can be easily modified based on current and future office space needs (estimated cost \$1.8 million)

Options:


- 1. Develop a remodeling plan and updated cost estimate for the 2023 Budget
- 2. Develop a plan for new carpet, cubicles, painting, etc. and a cost estimate for the 2023 Budget
- 3. Develop both Option 1 & 2 and present these options to the Commission prior to the 2023 Budgeting

New Addition:

- 1. 12 new office spaces
- 2. Returns Vector side to Vector Staff only
- 3. Could reduce the plan
  - Eliminate 6 offices which would allow for 3 additional future staff
  - Evaluate small conference room
  - Evaluate printer/plotter space



## **Casselton Soybean Crushing Facility**

## **Casselton Soybean Crushing Facility**



Indicates NDSU Ag Land – undevelopable land

Challenges: Proposed site has no paved road access and limited gravel road access. Expect 200-300 trucks per day

Opportunities: \$400 million project, \$130-\$150 million in property tax value

### Options:

- 1. Pave two miles of new roads
- 2. 50/50 Cost split with NDDOT
- 3. Cost of two miles of new road is roughly \$4 million

Current Status: The development group is expecting to decide if this project will move ahead on December 12th. ND Commerce Office is optimistic this project will move forward.




### **Road Issues**

- Total Length 1.5 Miles
- Soft Spots Subgrade Repair Project Needed to correct these issues.
- Costly for the Township to maintain gravel road section.
- Winter snowplowing issues
- Connects to a County Owned park therefore could this be a County Road?
- Options
  - Do Nothing
  - Repair Soft Spots Assist Township with Blading
  - Take it over as a county road and potentially pave the access road and campground.
- Currently Applying for grant funding for 50%
  of the gravel road regrading and subgrade repair
- We will continue to seek out other funding options

## **MetroCOG Interstate Operations Study**



- MetroCOG is conducting an Interstate Operations Study that will conclude in late 2022 or early 2023
- The study includes identifying future ring route locations around the east and west sides of the metro area
- The ND ring route locations being studied include the FM Diversion alignment from Argusville to I-94 and the Cass 15/Cass 14 corridors
