SUBJECT: Court Facilities Improvement Grant Application

The State of North Dakota annually awards grants to Counties for improvements made to Court facilities. Eligible projects must be a necessary improvement or essential to remodel or maintain court facilities.

Successful grant recipients will be awarded up to 75% of the cost of eligible projects, with Counties covering the remaining 25%. Applications are due by December 31, 2021.

Court personnel have recommended, and the County Building Committee has reviewed a potential project to convert a 3<sup>rd</sup> Floor video courtroom into a dual-purpose video courtroom/Jury Deliberation Room. This is needed because currently the only 3<sup>rd</sup> floor Jury Deliberation Rooms are only accessible through public areas, creating the potential for jurors to come in contact with court participants outside the courtroom.

The estimated project cost is \$80,000. If approved, \$60,000 of that amount would be covered by the grant. \$20,000 would be the responsibility of Cass County.

Court personnel and the County Building Committee have also reviewed a second potential project to replace three overhead counter doors in the court administration office that have to be hand cranked open and shut each morning and afternoon. The current overhead doors are in disrepair and the inability to quickly shut the doors presents a potential safety challenge.

#### **SUGGESTED MOTION:**

Authorize the Chair to review and sign both applications for Court Facilities Improvement Grant subject to change in total cost based on vendor quote.


