Chair Steen,

Cass County Sheriff's Office was approved to purchase a K-9 in our 2022 budget. Recently SCHEELS has approached our office and wants to partner with us to purchase the K-9. We have an opportunity to purchase a K-9 next Tuesday December 21<sup>st</sup>, from North Iowa K-9 in the amount \$14,500.00. North Iowa K-9 is the company that we have been working with to develop our training. Of course, purchasing the K-9 now would be out of budget and is not a specific line item in this year's (2021) budget. I am asking that we be allowed to purchase the K-9 next Tuesday out of Cass County Funds and our 2021 budget. SCHEELS will then reimburse Cass County Government for payment of the K-9. Purchasing the K-9 now will allow us to get an earlier start on the training and will also give us an early start on the implementation of our program. In addition, the West Fargo Police Department is purchasing a K-9 at the same time from the same company. That will allow the Cass County Sheriff's Office to train alongside the West Fargo Police Department.
