## Chair Steen,

On December 16<sup>th</sup>, 2021 I made the commission aware that Scheels was going to be reimbursing our agency for the purchase of a K-9. Initially I had made a line item budgetary request in the 2022 budget to purchase a K-9 which was approved. Because Scheels has now agreed to purchase a K-9 for us we still have the initial line item K-9 request in our 2022 budget. I am respectfully asking to be able to keep the initial line item request which would allow us to purchase an additional K-9. This would give us two K-9's which is what we had in the past. Two K-9's helps our agency in many ways. It allows us through scheduling to have a K-9 on opposite shifts to reduce calling other agencies to assist and to reduce our overtime costs. Our intention is to have dual purpose K-9's and by having two dogs we can increase our dual-purpose capabilities. From time to time we use our K-9's at our rural schools and in the jail. One K-9 in these situations is not conducive to the size of these structures and intentions. Often times a K-9 is only effective until the K-9 becomes tired. In addition, the Sheriff's Office has jurisdiction throughout Cass County and often assists other agencies. Having two K-9's would allow us to be better partners with our other agencies as we would more readily have a K-9 available upon request. Finally, in analyzing the maintenance costs of two K-9's we can within our 2022 budget maintain this responsibility.

## Suggested Motion

"Move to allow the Sheriff's Office to keep their initial budget line item request to purchase a K-9 allowing the Sheriff's Office to have two K-9's."
