SUBJECT: SCADA Network Firewall

Dear Commissioners,

Enclosed is a quote to purchase a pair of Palo Alto Firewalls to secure our Buildings Scada Network.

Background: In 2020, the IT Director applied for and was rewarded a grant for the ND Department of Emergency Services. This grant was a cyber security grant, and our award was specifically to provide phishing training to all County Staff and provide a more secure connection for our Building networks.

Due to the unexpected change the world went in 2020, these grants were started, but not finished over the next 18 months. Since my tenure has begun, I have been able to work with ND DES to extend the deadline for these grants, which was initially December 2021, and now have until August to complete them. To date, I have successfully completed, applied for, and been reimbursed for the cost of our Phishing training software

The attached quote is for a pair of Palo Alto Firewalls from High Point Networks, the vendor whom holds the state contract. These firewalls would be installed between the Cass proper network and the buildings network, allowing us to control what can get to our HVAC/Lighting/Camera systems in a much more robust way. This design has been discussed with Buildings and Grounds, and we all came to an agreement on the plan and the direction to move forward. The quote includes three years of licensing, after which Buildings and Grounds would absorb the license fee into their budget.

This is a non-budgeted request, however will be reimbursed 100% by the DES Grant as long as meet the timelines. I have no concerns on meeting the timelines with an order going in this month, as my staff are familiar with the Palo Alto equipment we currently have.

Approve purchase of a pair of Palo Alto Firewalls with three-year subscriptions from High Point Networks for \$22,723.
