Rick:

If you decide to authorize the Thunder Coffee Special Event Permit Request, I think we should return it to Thunder with these caveats, part of which I am capturing here for posterity.

- Brewer taproom licensees recognized by the ND Tax Department can apply for special event permits. As I understand it there are approximately 10 brewers which had done that by 3:30. All of those brewers were based in ND.
- It would be possible for brewers outside ND (e.g., MN and SD) to also apply for special event permits if they were brewer taproom licensees. However, b/c the rules governing this process may not be easily understandable by all, and/or the timing of sorting this out for this event was too short, none of them had done so.
- According to the Executive Director of the ND Brewer's Guild, they have made arrangements for the certain distributors to be available to assist in the process of making the out-of-state brews available for this event. In addition, I understand Thunder Coffee plays a role in this process.
- If a brewer is no a taproom licensee, they cannot themselves hand their brew to the customer. But they can explain their product to the customer.

The comments above are based upon discussions with the ND Tax Department, Skyler Dutton at Thunder Coffee, and the Brewers Guild Executive Director, amongst others, and what I can glean from a quick review of related statutes such as NDCC 5-01-21. I have encouraged the parties involved to work through this process at a much earlier time in the future.

With this all in mind, I don't see anything that would legally prohibit your authorization of the special events permit request by Thunder Coffee.
