My name is Ashley Hansen and I am with the Park Board in Harwood, ND. We are putting the finishing touches on our community celebration, Harwood-A-Rama coming up on August 6. For that celebration, we have a parade. The parade route does cross Highway 81 and go across County Road 17 through the main part of Harwood in front of the Petro Serve (Cenex). We are seeking a permit for a temporary closure for 1 hour from 12:45pm to 1:45pm for the parade to go through town. Please see the map for exact details.
