SUBJECT: Consider 2023 State's Attorney Salary

State's Attorney Mr. Birch Burdick is not seeking reelection and Cass County will have a new State's Attorney effective January 1, 2023. With the change in office leadership the Commission should consider setting the salary for the incoming State's Attorney.

There are two candidates seeking the office. Both are experienced attorneys within the State's Attorney's Office and both are currently at the same step & grade on the County pay matrix. (D62A Step 10 effective 01-01-23: \$127,421.13) Setting the incoming State's Attorney's salary now will provide clarity to the candidates and allow the County to ensure we avoid salary compression issues within the office.

Attached you will find a table of attorneys and salary breakdowns within the office. By county policy the successful candidate will receive a promotion and shall receive a salary increase of not less than 5%. That would place the successful candidate at a 004 Step 8: \$137,692.
