Subject: Highway Building Construction Contracts

On March 9th bids were received and opened for the general contractor, mechanical contractor and electrical contractor work related to the remodel and expansion of the Cass County Highway Administration Building. A total of five general contractor bids, five electrical contractor bids and five mechanical contractor bids were received with the lowest responsible bids are listed below:

General Contractor:	Diversified Contractors	\$1,898,800
Mechanical Contractor	Manning Mechanical	\$980,000
Electrical Contractor	Vinco	\$217,000
Total:		\$3,095,800

The construction total is approximately 4% higher than the architect's estimate of \$2,970,000. The Commission was briefed on this bid-opening at the meeting on March 20th, but the construction agreements were not complete at that time. Those contracts are now complete and presented for the Board's consideration at the meeting on April 20, 2023.

<u>SUGGESTED MOTION</u>: Authorize the Chair to sign General Contractor agreement with Diversified Contractors in the amount of \$1,898,800, Mechanical Contractor agreement with Manning Mechanical in the amount of \$980,000 and Electrical Contractor agreement with Vinco in the amount of \$217,000.

§ 5.1 Progress Payments

§ 5.1.1 Based upon Applications for Payment submitted to the Architect by the Contractor and Certificates for Payment issued by the Architect, the Owner shall make progress payments on account of the Contract Sum to the Contractor as provided below and elsewhere in the Contract Documents.

§ 5.1.2 The period covered by each Application for Payment shall be one calendar month ending on the last day of the month, or as follows:

§ 5.1.3 Provided that an Application for Payment is received by the Architect not later than the last day of a month, the Owner shall make payment of the amount certified to the Contractor not later than the twentieth day of the following month. If an Application for Payment is received by the Architect after the application date fixed above, payment of the amount certified shall be made by the Owner not later than forty-five (45) days after the Architect receives the Application for Payment.

(Federal, state or local laws may require payment within a certain period of time.)

§ 5.1.4 Each Application for Payment shall be based on the most recent schedule of values submitted by the Contractor in accordance with the Contract Documents. The schedule of values shall allocate the entire Contract Sum among the various portions of the Work. The schedule of values shall be prepared in such form, and supported by such data to substantiate its accuracy, as the Architect may require. This schedule of values shall be used as a basis for reviewing the Contractor's Applications for Payment.

§ 5.1.5 Applications for Payment shall show the percentage of completion of each portion of the Work as of the end of the period covered by the Application for Payment.

§ 5.1.6 In accordance with AIA Document A201[™]-2017, General Conditions of the Contract for Construction, and subject to other provisions of the Contract Documents, the amount of each progress payment shall be computed as follows:

- § 5.1.6.1 The amount of each progress payment shall first include;
 - That portion of the Contract Sum properly allocable to completed Work; .1

 - Any amount for which the Contractor does not intend to pay a Subcontractor or material supplier, .3 unless the Work has been performed by others the Contractor intends to pay;
 - For Work performed or defects discovered since the last payment application, any amount for which .4 the Architect may withhold payment, or nullify a Certificate of Payment in whole or in part, as provided in Article 9 of AIA Document A201-2017; and
 - Retainage withheld pursuant to Section 5.1.7. .5

§ 5.1 Progress Payments

§ 5.1.1 Based upon Applications for Payment submitted to the Architect by the Contractor and Certificates for Payment issued by the Architect, the Owner shall make progress payments on account of the Contract Sum to the Contractor as provided below and elsewhere in the Contract Documents.

§ 5.1.2 The period covered by each Application for Payment shall be one calendar month ending on the last day of the month, or as follows:

The property insurance shall be maintained until Substantial Completion and thereafter as provided in Section A.2.3.1.3, unless otherwise provided in the Contract Documents or otherwise agreed in writing by the parties to this Agreement. This insurance shall include the interests of the Owner, Contractor, Subcontractors, and Sub-subcontractors in the Project as insureds. This insurance shall include the interests of mortgagees as loss payees.

§ A.2.3.1.1 Causes of Loss. The insurance required by this Section A.2.3.1 shall provide coverage for direct physical loss or damage, and shall not exclude the risks of fire, explosion, theft, vandalism, malicious mischief, collapse, earthquake, flood, or windstorm. The insurance shall also provide coverage for ensuing loss or resulting damage from error, omission, or deficiency in construction methods, design, specifications, workmanship, or materials. Sub-limits, if any, are as follows:

To the extent commercially available, the additional insured coverage shall be no less than that provided by Insurance Services Office, Inc. (ISO) forms CG 20 10 07 04, CG 20 37 07 04, and, with respect to the Architect and the Architect's consultants, CG 20 32 07 04.

§ A.3.2 Contractor's Required Insurance Coverage

§ A.3.2.1 The Contractor shall purchase and maintain the following types and limits of insurance from an insurance company or insurance companies lawfully authorized to issue insurance in the jurisdiction where the Project is located. - damages because of physical damage to or destruction of tangible property, including the loss of use of .3 such property;
- bodily injury or property damage arising out of completed operations; and .4
- the Contractor's indemnity obligations under Section 3.18 of the General Conditions. .5

§ A.3.2.2.2 The Contractor's Commercial General Liability policy under this Section A.3.2.2 shall not contain an exclusion or restriction of coverage for the following:

- Claims by one insured against another insured, if the exclusion or restriction is based solely on the fact .1 that the claimant is an insured, and there would otherwise be coverage for the claim.
- Claims for property damage to the Contractor's Work arising out of the products-completed operations .2 hazard where the damaged Work or the Work out of which the damage arises was performed by a Subcontractor.
- Claims for bodily injury other than to employees of the insured. .3
- Claims for indemnity under Section 3.18 of the General Conditions arising out of injury to employees .4 of the insured.
- Claims or loss excluded under a prior work endorsement or other similar exclusionary language. .5
- Claims or loss due to physical damage under a prior injury endorsement or similar exclusionary .6 language.
- Claims related to residential, multi-family, or other habitational projects, if the Work is to be performed .7 on such a project.
- Claims related to roofing, if the Work involves roofing. .8
- Claims related to exterior insulation finish systems (EIFS), synthetic stucco or similar exterior coatings .9 or surfaces, if the Work involves such coatings or surfaces.
- Claims related to earth subsidence or movement, where the Work involves such hazards. .10
- Claims related to explosion, collapse and underground hazards, where the Work involves such hazards. .11

§ A.3.2.3 Automobile Liability covering vehicles owned, and non-owned vehicles used, by the Contractor, with policy limits of not less than One Million (\$ 1,000,000) per accident, for bodily injury, death of any person, and property damage arising out of the ownership, maintenance and use of those motor vehicles along with any other statutorily required automobile coverage.
