Purchase of Copy Machines

Dear Commissioners,

Enclosed is a proposal to replace two aging copiers in the State's Attorney's Office.

On a daily basis, my office generates a large amount of printed and copied material. As such, a robust copier fleet is a critical need for us. Working with our internal IT department, we have determined it is time to replace two of our most aged copiers with modern units. This purchase would fall within the State's Attorney's budget line item 101-3101-419-74-02, office equipment. In 2023, \$15,000 was budgeted for that line item.

We have solicited quotes from various vendors, and selected Liberty as our front runner. This has the added benefit of allowing us to "pool" our copies among multiple units, leading to lower overages than if we were to have multiple agreements from multiple vendors. Our IT department confirmed the selected copiers meet our needs as well as IT's requirements for deployment.

SUGGESTED MOTION:

Move to approve the purchase of two copiers from Liberty Business at the cost of \$7,262.04 each, for a total of \$14,524.08 from State's Attorney's line item 101-3101-419-74-02.
