

**REGULAR MEETING OF CASS COUNTY BOARD OF COMMISSIONERS
MAY 1, 2023**

1. MEETING CALLED TO ORDER

Chairman Chad M. Peterson called the meeting to order at 3:30 PM with all members present as follows: Tony Grindberg, Duane Breitling, Jim Kapitan, Mary Scherling, and Chad M. Peterson.

2. PLEDGE OF ALLEGIANCE

Taylor Kaushagen led the Pledge of Allegiance.

3. MINUTES APPROVED

MOTION, passed

Mr. Breitling moved and Mr. Kapitan seconded that the minutes of the previous meeting be approved as written. Motion carried.

4. AGENDA, Order approved

MOTION, passed

Mr. Breitling moved and Mr. Grindberg seconded to approve the order of the agenda. Motion carried.

5. CONSENT AGENDA APPROVED

MOTION, passed

Mr. Kapitan moved and Mrs. Scherling seconded to approve the consent agenda as follows: On roll call vote, the motion carried unanimously.

- a. Ratify actions of the Personnel Overview Committee from the meeting held on April 17, 2023, and amend Employee Handbook Policies 515 Telecommuting and 111 Job Posting as presented.
- b. Authorize purchase of data tracking and participant assistance annual subscription for the Community Supervision program with Promise, Inc in the amount of \$15,000; purchase of road intersection lighting with Parsons Electric in the amount of \$24,275; purchase of two copy machines for the State's Attorney's Office from Liberty Business in the amount of \$14,524.08 from line item 101-3101-419-74-02; and purchase of striping and seal coat of the Law Enforcement Center parking lots from Advanced Striping and Sealcoating in the amount of \$10,736.
- c. Authorize Chair to sign builders risk insurance policies with Hanover Insurance Group in the amount of \$49,574 for the Jail Housing Addition project and \$8,574 for the Highway Addition/Remodel project.
- d. Contract approval—Authorize Chair to sign contracts for mosquito control activities.

6. PUBLIC COMMENT

Mr. Peterson asked for public comment and hearing none, moved on to the regular agenda items.

7. FINANCE OFFICE, 2024 budget calendar approved

County Finance Director, Brandy Madrigga was present and said for the Board's consideration is the 2023 budget calendar. She said the schedule is consistent with prior years and begins in May and ends in October. Ms. Madrigga said budgets will be due from Departments to the Finance Office on June 30, the Commission will hold budget hearings on July 28, 29, and 30, the preliminary budget will be considered at the August 7 Commission meeting, and the final budget hearing will be considered at the September 18 Commission meeting as the Commission must approve the tax levy to support the budget no later than October 1 per the County's Home Rule Charter.

County Administrator, Robert Wilson was present and said the County has been working with its salary consultant, Gallagher, to complete a salary survey and get options to implement a pay matrix with fewer steps. He said he and Human Resource Director, Tracy Peters met with Gallagher last

week and Gallagher will have a tight timeline to submit their findings for the salary study to implement during the budgeting process. He said Gallaher will submit the findings they have by the first week of July and will be implemented with the 2024 budget proposal during budget hearings. He said these findings will likely be 90% to 95% complete and will be finalized by August.

MOTION, passed

Mr. Grindberg moved and Mr. Kapitan seconded to approve the budget calendar presented by the Finance Office for preparing and approving the 2023 Cass County Budget. Motion carried.

8. INFORMATION TECHNOLOGY, Purchase of firewalls approved

County Information Technology (IT) Director, Bob Henderson, was present and said on March 6 the Board accepted the Infrastructure Investment and Jobs Act (IIJA) grant in the amount of \$170,000. He said the request now is to utilize the grant funding to purchase two firewalls, accessories, and 36 months of subscription services. Mr. Henderson said the grant will cover 90% of the purchase, the state will reimburse 5%, and the County will cover the remaining 5% within the current IT budget.

Mr. Grindberg asked if this is a one-time cost. Mr. Henderson said this is not a one-time cost, this purchase will cover the subscription of the firewalls for 36 months and after the County will replace its current subscription amount of \$36,000 through the State with the new system at a yearly cost of \$34,616.

MOTION, passed

Mrs. Scherling moved and Mr. Kapitan seconded to authorize the IT Director to purchase two Palo Alto firewalls as presented with county funds to be reimbursed after project completion by NDDes at a rate of 95%. On roll call vote, the motion carried unanimously.

9. ROAD, Public hearing on road closures set for June 5, 2023

The County has been working with the Metro Flood Diversion Authority (FMDA) and Cass County Joint Water Resource District (CCJWRD) on road closures for the construction of the FM Diversion Project. In April of 2021, Cass County, FMDA, and CCJWRD approved a Memorandum of Understanding for the construction of the Diversion over road rights-of-way (ROW). County Assistant Engineer, Matthew Stamness was present and said the County is being asked by the FMDA and CCJWRD to prepare to close portions of County Road 40/37th Street Southeast and County Road 8/40th Avenue West that will be impacted by Phase 3 of the FM Diversion storm water diversion channel and associated infrastructure (SWDCAI). Mr. Stamness said pursuant to the terms of the MOU, the next steps are to set a date and time for a public hearing on the requests. He said once the public hearing is set, the Highway Department will send notices of the public hearing to landowners within 1,000 feet of the closures at least 30 days prior to the hearing. He said the request is to set the public hearing for Monday, June 5, 2023 during the regular meeting of the Cass County Commission. He said following the public hearing, the Board will be asked to approve a resolution to grant written permission to permanently obstruct the same and underlying section lines of each road.

Mrs. Scherling asked how many more of these road closure requests will be brought to the Commission. Mr. Stamness said for this portion of the project, there will likely be three more requests.

MOTION, passed

Mr. Grindberg moved and Mrs. Scherling seconded to set a public hearing for June 5, 2023 during the regular meeting of the Cass County Commission for a resolution to grant written permission to permanently obstruct County Road 40/37th Street Southeast and County Road 8/40th Avenue West. On roll call vote, the motion carried unanimously.

10. ROAD, 2023 Spring flood update

County Engineer, Jason Benson was present and discussed 2023 spring flood activities. He said on the weekend of April 22, the Red River in Fargo and Sheyenne River in Harwood crested below

what was originally projected due to colder than average temperatures and lower than average precipitation. He said the Red River at Hickson was planned for a crest at 35.4 feet and actually crested at 28.2, the Red River at Fargo was planned for a crest at 37.8 and actually crested at 29.7, the Wild Rice at Abercrombie was planned for a crest at 24.0 and crested at 18.4, the Sheyenne River at Kindred was planned for a crest at 21.2 and crested at 19.9, the Red River at Harwood was planned for a crest at 92.1 and crested at 90.3, and the Maple River at Mapleton was planned for a crest at 23.2 and crested at 22.3. Mr. Benson said 31,100 empty sandbags with loads of sand and 50,000 filled sandbags were delivered the week of April 13. He said the tactical operations center (TOC) was open from April 21 to April 24 from 7 AM to 7 PM to answer flood calls. Mr. Benson said there were some road closures and the Highway Department is now working to reopen roads, and assess and fix damage. He said most road damage is minor.

11. JAIL, Housing Addition contracts approved

Mr. Wilson said at the Board's last meeting on April 17, the low bids for the Jail Housing addition were approved. He said the request today is to approve the contracts with the low bidders, Meinecke-Johnson as the general contractor for \$16,343,500, Peterson Mechanical as the mechanical contractor for \$5,897,700, and Vinco as the electrical contractor for \$4,302,315. The total project contract price is \$26,543,515.

MOTION, passed

Mr. Kapitan moved and Mr. Breitling seconded to Authorize the Chair to sign construction agreements with Meinecke-Johnson in the amount of \$16,343,500, Peterson Mechanical in the amount of \$5,897,700 and Vinco in the amount of \$4,302,315 for the Jail Housing Addition project. On roll call vote, the motion carried unanimously.

12. VOUCHERS, Approved

MOTION, passed

Mr. Grindberg moved and Mr. Breitling seconded to approve Voucher No. 336282 through Voucher No. 336624 for a total of \$1,836,002.31. On roll call vote, the motion carried unanimously.

13. MEETING UPDATES, Committee reports

Commissioners and staff reported on meetings they have attended or will be attending in the upcoming weeks.

Mr. Wilson said the Administration Office has worked to fill the Camp Host Position for Brewer Lake, and the successful candidate is Vicki Bender. He said a background has been completed for Ms. Bender and her spouse, and since they are contracted with the County, liability insurance is not needed.

Mr. Wilson said he is proposing a meeting of Commissioners and Department Heads to discuss how information will be presented to the Board during budget hearings with the new accounting system on May 15 at 11:30 AM.

Mr. Wilson said the County held the National Association of Counties (NACo) Mental Health First Aid (MHFA) training that was purchased earlier this year. He said the material was well received and helpful for employees. Mr. Peterson said he would like additional information on the participation rate of the training.

Mr. Benson said work will begin on the County Highway 17 project between 68th Avenue and Deer Creek Parkway South in West Fargo. He said phase one of the project will consist of constructing a roundabout at the intersection of 64th Avenue South and County Highway 17. He said the project will begin on May 8 and will likely be completed on August 18. He said the Highway Department held public meetings and worked with local leaders to inform the public of the work.

14. ADJOURNMENT

MOTION, passed

On motion by Mr. Kapitan, seconded by Mr. Breitling and all in favor, the meeting was adjourned at 4:47 PM.
