SUBJECT: Consent Agenda Item for July 5, 2023 Commission Meeting: Bridge Repair -C15 – 8/9 Mapleton Twp in Cass County.

This bridge was replaced in 2022. Unfortunately, the south end of the bridge was hit by a snowplow this winter due to some settlement on the south abutment. It ended up damaging the bridge and it needs repair.

Industrial Builders reconstructed the bridge and offered to do a cost share to repair the bridge due to the settlement that happened after construction. The total cost of the repairs including bridge repair, asphalt patching, and traffic control comes to \$45,175.00. Industrial Builders offered to cost share \$10,000 of the bridge repair portion of the costs. The total cost due to the county for the remainder would be \$35,175.00.
