Biographies of the 2023 Candidates





Lisa Helbling, West Fargo, retired, held the role of Chief Financial Officer (CFO) from 2011 - 2022. She was the former CFO of ImmunoPrecise Antibodies, Ltd (NASDAQ: IPA). Prior to IPA, Helbling was CFO of Anchor Ingredients and CFO of TMI Hospitality. Helbling has 37 years of experience in finance, accounting, strategic planning, enterprise risk management and audit. Her industry experience includes hospitality, electric utility, biotech, manufacturing, construction, transportation, life insurance, and public accounting. Lisa currently serves on the Board of Directors of Border States Industries and is the chair of the Audit Committee. She holds a bachelor's degree in accounting from Moorhead State University and business administration from North Dakota State University, is a certified public accountant, is certified by the National Association of Corporate Directors (NACD) and is certified in Cybersecurity Oversight by NACD. Helbling joined the BCBSND Board in 2017 and was the Chair of the Audit and Compliance Committee for five years and currently is the chair of the Finance and Investment Committee and is serving as the Vice Chair.
