We are writing to express our support for the application submitted by Cass County, North Dakota to the Fiscal Year (FY) 24 Rebuilding American Infrastructure with Sustainability and Equity (RAISE) Transportation Grants Program. Thank you for your consideration.

Currently Cass County Highway 10 between Tower City and Buffalo and through Buffalo play a significant role in Cass County's transportation network, and the economy of eastern North Dakota. These stretches of highway support significant economic activity from the local farm community, as well as commuter traffic to the urban areas to our east. County Road 10 was previously US Highway 10 prior to the construction of I-94, and therefore retains a significant role as a parallel connector corridor across Cass County. However, without the proposed grading and surfacing improvements these corridors risk falling out of a state of good repair, as they currently rate among the worst pavements in Cass County.

The project also includes strategic investment in multimodal facilities through Tower City and Buffalo supporting the mobility of residents all ages without access to automobiles are who may choose to travel by biking or walking.

Cass County is therefore proposing a total reconstruction of these roadways including grading, paving, culvert replacement and flood damage prevention. The project would also widen and pave the shoulder and improve slopes and drainage along the corridor, meeting standards set by the North Dakota Department of Transportation (NDDOT). The project will also enhance trucking and freight movements to major agricultural commodity process and storage sites located in central Cass County, supporting the largest sector of the regional economy.
