Subject: Purchase tile, thin set, grout, and metal trim for south end bathrooms on the second

floor and in the basement of the Courthouse

The 2025 budget includes \$50,000 to complete a remodel of the south end bathrooms on the second floor and in the basement of the Courthouse. Part of the remodel work was approved earlier this year in the amount of \$14,410. The request today is for the tile, thin set, grout, and metal trim to complete the project. Buildings and grounds received a quote from Fargo Linoleum Co. for the materials in the amount of \$10,710.

Subject: Emergency repair work on hot water heat exchanger at the Jail

Two weeks ago, Buildings and Grounds discovered two hot water heaters at the Jail have sprung leaks due to the heat exchangers. The water tanks are fine and warranted for 25 years. The heat exchangers are warrantied for 5 years with one installed in 2017 and the other a few years prior, thus they are both out of warranty.

Buildings and Grounds received a quote from Brekke Sales Company for both of the heat exchanger replacements in the amount of \$30,832. Buildings and Ground Supervisor Gene Gartner estimates the cost of replacing the entire water heater and heat exchanger at \$60,000 each.

This is a non-budgeted expense. Mr. Gartner said if no further LED lights are installed this year, we could use that money to cover this expense and would not require a budget adjustment.

<u>SUGGESTED MOTION:</u> Retroactively authorize emergency purchase of two heat exchangers for the Jail from Brekke Sales Company in the amount of \$30,832.
