

SUBJECT: Consent Agenda Item for June 3, 2024, Cass County Commission. Purchase of Walk N Roll Packer.

The 2024 budget included the purchase of a new snowblower for \$30,000. We have another piece of equipment that we would like to purchase in lieu of the snowblower for 2024. We have owned a Walk N Roll packer since 2004 and would like to upgrade to a newer and updated model. This is an attachment that goes on our motor graders and helps compact the gravel after blading it. We solicited quotes and can purchase a new WR90-3 Oscillator Walk N Roll and trade in our current model. LyCox Enterprises, Inc. has quoted us a price of \$36,640.00. This cost would be included in our 2024 budget for Heavy Equipment.

We feel that by upgrading the packer this year, and not spending more money on the maintenance of the existing packer, we will be saving in the long run. The mild last winter also wasn't hard on our existing snowblower, so it has more life left in it. But we plan to include a new snowblower in the 2025 budget. A budget adjustment was approved earlier this year for the 2 Tandem Trucks, a Pickup, and Truck Boxes that we have been waiting years to arrive. The savings of remaining Heavy Equipment item prior purchases for 2024 will cover the extra \$6,640.00 above the snow blower budgeted amount.
