Subject: Amend Commission Policy Manual Section 4.00 Advisory Boards, Maple River WRD

Due to a recent resignation, there is a vacancy on the Maple River Water Resource District Board. It is the responsibility of the County Commission to appoint Water Resource District (WRD) members.

A press release was issued seeking qualified applicants to serve as an interim board member to serve from October 8, 2024, to December 31, 2024, when the current term will expire. The Commission Office received three applications for the Maple River WRD Board position from: Dallas Hoffman, Mark Sahli, and Jeffrey Askew.

According to the application of Mark Sahli, Mr. Sahli does not live within the Maple River WRD boundaries. After consultation with the State's Attorney's Office and in accordance with N.D.C.C. 61-16-08, "When a water resource district has been created, any resident landowner in the district, except a county commissioner, is eligible, subject to the provisions of this section, for appointment to the water resource board." The State's Attorney's Office has suggested the use of both the words "resident" and "landowner" mean that the WRD member must live in the district to be eligible for appointment.

The request today is for the Commission to appoint one of the two eligible applicants, Dallas Hoffman or Jeffrey Askew, to fill the vacant term effective October 8, 2024, to December 31, 2024.

Other current open Board positions include:

- City Planning and Zoning Boards of Fargo, Gardner, Harwood, Mapleton, North River, Oxbow, and West Fargo from the extra-territorial area
- Southeast Human Services Board
