Subject: Special Meeting – Courtroom Remodel Project Preferred Bidders

On Thursday, November 21, 2024, sealed bids were opened for general contractor, mechanical contractor and electrical contractor services on the Cass County Courtroom Remodel Project. Eight general, four mechanical, and seven electrical bids were received. The low bids were:

General Contractor: Grafstrom Construction \$789,500.00
Mechanical Contractor: Robert Gibb & Sons \$185,500.00
Electrical Contractor: Sun Electric \$160,000.00

Project Architect Steve Skoblik of Foss Architecture+Interior has reviewed the bids and recommends identifying the low bidders as 'preferred bidders' and initiating contract negotiations consistent with the terms identified in the sealed bids.

At the Special Commission Meeting at 2:00 p.m. on Tuesday, November 26, 2024, the Board may consider the following motion:

<u>Motion:</u> Recognize the low bidders, Grafstrom Construction – General, Robert Gibb & Sons – Mechanical and Sun Electric – Electrical, as the 'preferred bidders' and authorize county staff to negotiate agreements with each party consistent with their sealed bids.
