SUBJECT: Agenda Item for February 3rd, 2025 Commission Meeting: Highway Department Budget Adjustment & Concrete Box Culvert Quotes.

This past fall the bridge construction on C32 – 22/27 Amenia Twp over the Rush River was substantially completed. This project was in the budget in 2024 and 2025 because of the unknown of the contractors start date. Due to the construction being substantially completed in 2024, only \$50,000 of the \$350,000 budgeted in 2025 will be used, leaving \$300,000 remaining.

Therefore, the decision was made to bid one more Concrete Box Culvert Project in 2025 to take advantage of the excess money available in the 2025 budget.

Therefore, we are respectfully submitting a budget adjustment request in the amount of \$232,904 to the bridge construction budget line item 211-4001-431-45.50.

Attached are the documents for Rinker Materials for 5 culvert projects to be installed by county forces. A request for quotes was sent to four different suppliers Oldcastle Infrastructure, Engineered Concrete Products, Cemcast Pipe & Precast, and Rinker Materials. The bids were received as follows.

- TB2305 – Sections 11/12N Wheatland Twp.
