One of the structures is currently closed with the remaining two load posted. Rural communities in Cass County have been subjected to lengthy detours.

RE: Revitalizing Connections across the Red River of the North

Dear Secretary Buttigieg,

We respectfully request your support of a grant from the 2025 Rebuilding American Infrastructure with Sustainability and Equity (RAISE) program. Cass County, North Dakota, is partnering with Polk County, Minnesota, and requesting funding for a three-bridge-bundle to restore surface transportation across the Red River of the North. Your support to correct this transportation issue is urgently needed.

North Dakota Bridges 49-129-10.0, 49-131-28.0, and 09-142-10.0, were originally constructed with federal funds. Unsafe conditions lead to closure of Bridge 49-129-10.0, and load posting of the other two. Rural communities in Cass County and four others have been subjected to lengthy detours, decreased emergency response times and economic hardships. The current bridge infrastructure is dilapidated and has halted freight transit of goods and services and hindered the agricultural industry in both Minnesota and North Dakota.

Our goal is to restore surface transportation which will improve safety, and environmental conditions by removing lengthy detours. It will remove barriers and improve economic competitiveness and opportunity, ultimately improving the quality of life in Cass County and four others.

We urge you to invest in the Red River Valley region by funding the Revitalizing Connections across the Red River of the North application for funding in 2025. Thank you.
