# MEMO

TO: County Commissioners FROM: Kriste Ross, Coroner DATE: March 11, 2025 SUBJECT: DOORBELL VIDEO SYSTEM

The Cass County Coroner's Office has become more frequently visited by members of the public, deliveries, law enforcement, and others. Additionally, the space to the east of the Coroner's office has served as a substation for law enforcement and now a warming shelter. Due to the physical location of the office, as well as our duties, it is sometimes difficult to know that a person has arrived and is outside a door waiting. Often, individuals present to the office without notice or appointment. Due to the numerous doors of the Fargo Cass Public Health building, it is a common occurrence for deliveries to be left at the wrong door, leading to packages potentially being lost or misplaced.

The attached quote covers installing a 2 Door Video Doorbell system. The cameras would connect to small screens within the coroner's office, allowing us to not only be notified of someone at our doors, but also give us the ability to view them prior to admittance for security. In addition, the proposed system includes mobile device access for when staff are working outside of the office.

This system has been vetted by the City of Fargo, the owners of the FCPH building, and is currently being used in other buildings throughout the city. The quote includes the required hardware, software, wiring, and a full installation for this system. This quote was procured with the assistance of the Cass County IT department, who has also vetted the proposed system and approved.

Suggested Motion:

Authorize the Coroner's Office to purchase the 2N Camera System, including professional services for installation, for the sum of **\$7,929.00**.
