Subject: 2025 Final Innovate28 Funding Request

The 2025 County Budget included a \$2,500,000 appropriation to fund the County's portion of the Innovate28 program. Authorized as a 50/50 match between Cass County and the public sector, the initiative is designed to enhance our regional workforce, boost economic growth, and position the Fargo-Moorhead-West Fargo area as a premier destination for business expansion.

The County's partners in Innovate28, The Chamber and the Greater Fargo Moorhead Economic Development Corporation (GFMEDC) will brief the Board at the April 7<sup>th</sup> meeting and provide the total private sector contributions. A funding request from Cass County in an equal amount is anticipated.

On November 18, 2024 the Commission authorized a payment of \$1,200,000 of the authorized \$2,500,000 in recognition of private sector contributions collected to that point. As a result, the Commission may wish to consider a motion authorizing payment equal to an amount not to exceed \$1,300,000 dependent upon the total private sector Innovate28 contributions reported at the meeting.
