Re: Precinct Boundaries for 2016

Dear Commissioners:

State law requires the county to have precinct boundaries & polling locations set before December 31st. At this time the only change to precinct boundaries we are proposing for 2016 will be in District 16. There has been rapid growth in that district over the last several years. In order to manage the number of voters in the southern portion of that district, we are proposing the division of what used to be 16-03 into 2 precincts. The area that will remain precinct 16-03 will vote at Scheels Arena. We will be utilizing the concourse area to accommodate the increased number of voters. The area split off to create precinct 16-04 will vote at Journey in Faith Church. The only other change being made is the polling location for precinct 13-03 from Veterans Memorial Arena to the Cambria Suites. Parking has become a large concern during the General Elections and in our experience with early voting, the Cambria Suites works very well and will accommodate a large number of voters.

We reviewed each of the other polling sites in the county and believe we have excellent polling sites that can both handle the volume of voters and are at the same time convenient for the voter.

I have included list of polling locations, a map of legislative district 16 showing the revised precinct boundaries, and the legal descriptions of those precincts. For specific information or maps on the other legislative districts, they are posted on our website at

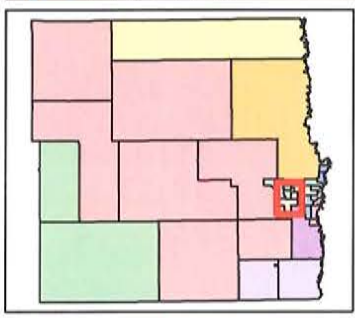
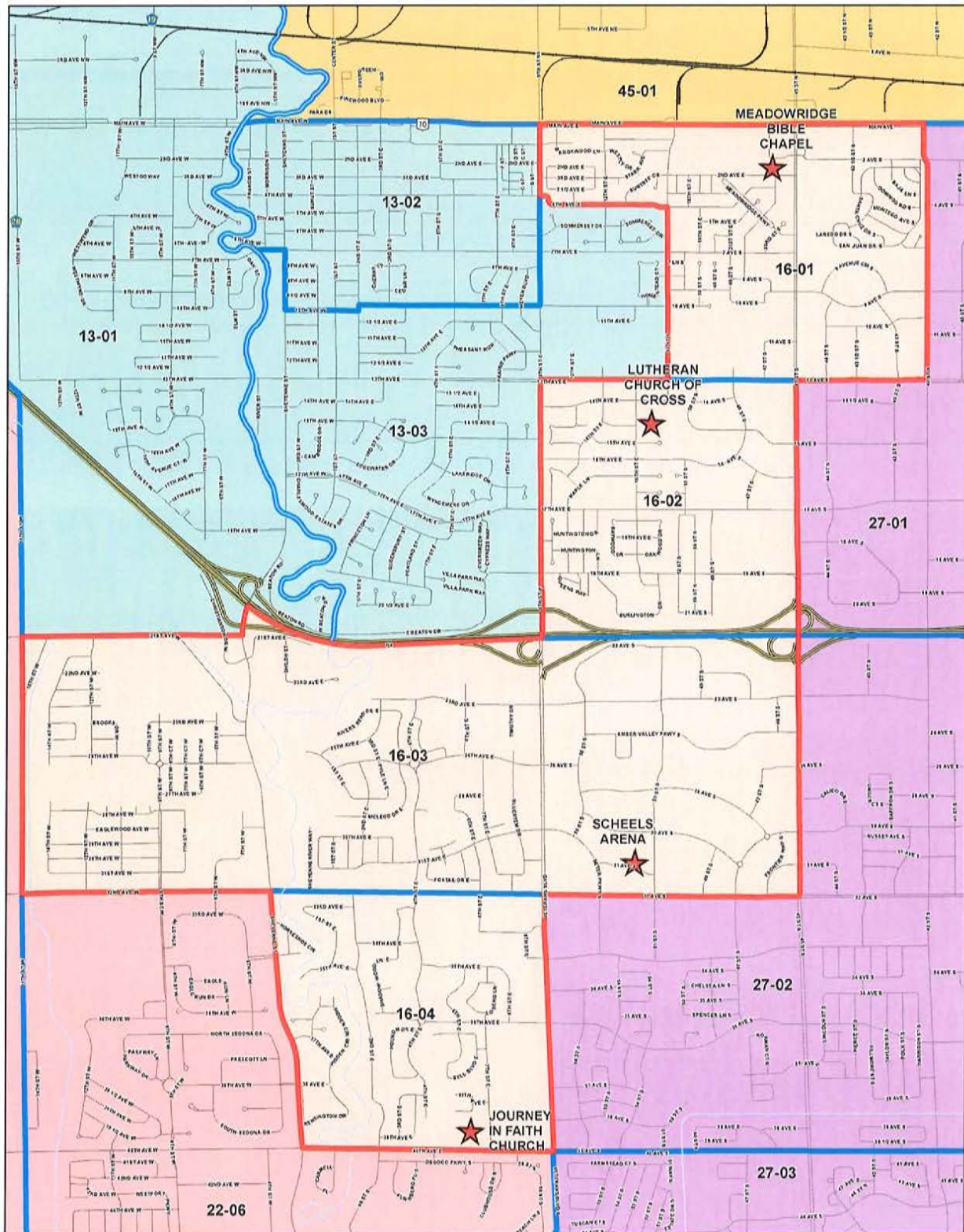

## DISTRICT 16 PRECINCTS - BRIEF DESCRIPTIONS

### District 16

This district covers a portion of the cities of West Fargo and Fargo.

### Meadowridge Bible Chapel, Precinct #09-16-01

This precinct covers part of an area in the cities of Fargo and West Fargo north of 13th Ave. S., west of 42nd St. S., south of Business Interstate 94, also identified as Main Avenue, and east of 9th Street East.

### Lutheran Church of the Cross, Precinct #09-16-02

This precinct covers part of an area in the cities of Fargo and West Fargo north of Interstate Highway 94, west of 45th St. S., south of 13th Ave. S. and east of the 9th St. E.

### Scheels Arena, Precinct #09-16-03

This precinct covers part of an area in the cities of Fargo and West Fargo north of 40th Ave. E., west of 45th St. S., south of Interstate Highway 94 and east of 15th St. W.

### Journey in Faith Church, Precinct #09-16-04

This precinct covers part of an area in the city of West Fargo north of 40<sup>th</sup> Ave. E., west of Veterans Boulevard, South of 32<sup>nd</sup> Ave E and east of Sheyenne St.

## LEGAL DESCRIPTIONS

District 16 consists of that part of Barnes Township and the cities of Fargo and West Fargo in Cass County bound by a line commencing at the centerline of Business Interstate Highway 94, also identified as Main Avenue, and the centerline of Forty-second Street in Fargo, then west on Business Interstate Highway 94 until its intersection with the centerline of Ninth Street, then south on Ninth Street until its intersection with the centerline of Fourth Avenue East, then east on Fourth Avenue until its intersection with the centerline of Seventeenth Street, then south on Seventeenth Street until its intersection with the centerline of Thirteenth Avenue East, then west on Thirteenth Avenue until its intersection with the centerline of Ninth Street, then south on Ninth Street until its intersection with the centerline of Interstate Highway 94, then west on Interstate Highway 94 until its intersection with the centerline of Sheyenne Street, then south on Sheyenne Street until its intersection with the centerline of an extended straight line from Twenty-first Avenue West, then west on that line and Twenty-first Avenue until its intersection with the east boundary of Mapleton Township, then south on the east boundary of Mapleton Township until its intersection with the centerline of Thirty-second Avenue, then east on Thirty-second Avenue until its intersection with the centerline of One Hundred Seventieth Avenue Southeast, also identified as Sheyenne Street, then south on One Hundred Seventieth Avenue until its intersection with the centerline of Fortieth Avenue East, then east on Fortieth Avenue until its intersection with the centerline of Veterans Boulevard, then north on Veterans Boulevard until its intersection with the centerline of Thirty-second Avenue, then east on Thirty-second Avenue until its intersection with the centerline of Forty-fifth Street, then north on Forty-fifth Street until its intersection with the centerline of Thirteenth Avenue South, then east on Thirteenth Avenue until its intersection with the centerline of Forty-second Street, then north on Forty-second Street to the point of beginning.

### Precinct #09-16-01 Meadowridge Bible Chapel

Beginning at the intersection of the centerline of Business Interstate Highway 94, also identified as Main Avenue, and the centerline of 42<sup>nd</sup> St. S., then west on Business Interstate Highway 94 until its intersection with the centerline of 9<sup>th</sup> St. E., then south on 9<sup>th</sup> St. E. until its intersection with the centerline of 4<sup>th</sup> Ave. E., then east on 4<sup>th</sup> Ave. E. until its intersection with the centerline of 17<sup>th</sup> St. E., then south on 17<sup>th</sup> St. E. until its intersection with the centerline of 13<sup>th</sup> Ave. S., then east on 13<sup>th</sup> Ave. S. until its intersection with the centerline of 42<sup>nd</sup> St. S., then north on 42<sup>nd</sup> St. S. to the point of beginning.

### Precinct #09-16-02 Lutheran Church of the Cross

Beginning at the intersection of the centerline of 13th Ave. S. and the centerline of 45th St. S., then west on 13th Ave. S. until its intersection with the centerline of 9th St. E., then south on 9th St. E. until its intersection with the centerline of Interstate Highway 94, then east on Interstate Highway 94 until its intersection with the centerline of 45th St. S., then north on 45th St. S. to the point of beginning.

Precinct #09-16-03 Scheels Arena

Beginning at the centerline of Interstate Highway 94 and the centerline of 45<sup>th</sup> St. S., then west on Interstate Highway 94 until its intersection with the centerline of Sheyenne Street, then south on Sheyenne Street until its intersection with the centerline of an extended straight line from 21<sup>st</sup> Ave. W., then west on that line and 21<sup>st</sup> Ave. W. until its intersection with the east boundary of Mapleton Township at 15<sup>th</sup> St. W., then south on the east boundary of Mapleton Township until its intersection with the centerline of 32<sup>nd</sup> Ave. W., then east on 32<sup>nd</sup> Ave. W. until its intersection with the centerline of 45<sup>th</sup> St. S., then north on 45<sup>th</sup> St. S. to the point of beginning.

Precinct #09-16-04 Journey in Faith Church

Beginning at the centerline of 32<sup>nd</sup> Ave. E. and the centerline of Veterans Blvd., then west of 32<sup>nd</sup> Ave. E. until its intersection with the centerline of Sheyenne Street, then south on Sheyenne Street until its intersection with the centerline of 40<sup>th</sup> Ave. E., then west on 40<sup>th</sup> Ave. E. until its intersection with the centerline of Veterans Blvd., then north on Veterans Blvd. to the point of beginning.
