The City of Fargo and the Cass County Commission has refused to provide property appraisals in preparation for the possibility of mitigation. We therefore request that the cost of privately obtaining an appraisal be deducted from our next property tax statement. These privately obtained property appraisals will provide the Local Sponsors and Cass County taxpayers with an accurate cost of mitigation of these properties, and give us the ability to be financially prepared for what may come in the future years.

Additionally, we request that any capital improvements be added into the appraisal amount and the total be given a 4% annual increase each year until mitigation occurs.
