Subject: RRRDC Dispatch Center – HVAC Commissioning

Proof of an HVAC Commissioning agreement is a pre-condition for issuing a City of Fargo Building Permit for the RRRDC Dispatch Center. The service will be ongoing throughout the construction project with the contractor responsible for verifying all systems are installed and operating properly.

Project architect SEH has obtained three quotes for the service ranging from \$20,000 - \$35,000. The low bidder is The Design Group at \$20,000. This expense is not included within the estimated total cost of construction.

The Red River Regional Dispatch Center Authority Board recommended authorizing this expenditure at its meeting on June 13<sup>th</sup>. The County Commission is asked to approve the attached agreement at the June 17<sup>th</sup> meeting.

Thank you for the opportunity to submit this Proposal for HVAC and Lighting Controls Commissioning Services for the Red River Dispatch Center Project. Short Elliott Hendrickson Inc. (SEH) is pleased to present you with the following fee proposal for additional services as noted above.

Our original agreement dated June 5, 2023 will be amended to incorporate these additional services and fees as listed below upon your approval of this amendment.

#### **Project Understanding**

Cass County is seeking commissioning (Cx) services from a qualified engineering firm to assess the Red River Regional Dispatch Center (RRRDC) project in Fargo, North Dakota. - Primary heating systems
- Lighting systems
- Domestic hot water equipment
- Humidity control equipment

The following services and deliverables will be provided as part of the commissioning services:

• Development of a Commissioning Plan

- Review of HVAC and lighting controls shop drawings provided by the building contractor
- On-site functional testing of building systems
- Development of a draft commission report
- One (1) site visit to retest various systems after contractor modifications
- Review of contractor provided Testing and Balancing (TAB) Report
- Final Commissioning Report
- Three (3) site visits during construction to review and observe mechanical and electrical system installation

**Schedule:** Commissioning services will be coordinated with the construction schedule and services provided as the construction reaches the appropriate milestones. A more detailed commissioning schedule may be provided once the construction schedule is finalized.
