## Regional Conservation Partnership Program (RCPP) - Upper Maple River Watershed public scoping / plan update meeting

Pat Downs welcomed everyone to the RCPP - Upper Maple River Watershed public scoping / plan update meeting and introductions were made. Christi Fischer stated the purpose of the meeting is to re-conduct the initial public scoping meeting as the RCPP – Upper Maple River Watershed Plan is now required to proceed through the Natural Resources Conservation Service (NRCS) Environmental Impact Statement process rather than the previously-conducted Environmental Assessment process. Ms. Fischer presented a summary of the RCPP – Upper Maple River Watershed planning process todate and discussed the goals and objectives of the Plan, including flood damage and nutrient reduction. Through the planning process, project alternatives were identified and evaluated. One project alternative, alternative #2A, remains in the Plan. Discussion was held on the currently planned design features of alternative #2A.

Rita Harmsen-Sveen next discussed the National Environmental Policy Act responsibilities and initial scoping concerns regarding the RCPP – Upper Maple River Watershed Plan such as soil erosion, water quality, plant and animal habitats and human environmental matters.

Additional discussion was held on the currently planned design features of alternative #2A of the RCPP – Upper Maple River Watershed Plan. Discussion was held on a potential meeting with impacted property owners on-site to discuss the preliminary plans for alternative #2A of the RCPP – Upper Maple River Watershed Plan. The Board directed Moore Engineering, Inc. to coordinate with the NRCS to schedule a meeting with impacted property owners on-site of alternative #2A of the RCPP – Upper Maple River Watershed Plan.
