Subject: NDPERS Update

I have been in discussions with PDL Connect Consulting, LLC, about bringing in a one-day leadership training called "Drive the Road Leadership Course" for our department heads and supervisory staff. PDL Connect is owned and operated by former sheriff Paul Laney and former Red River Dispatch Center Director Mary Phillippi. The Sheriff's Office has brought this training to their staff in the past and they are bringing in the "advanced" course in 2025.

We are planning to schedule the training January 23, 2025, from 8:00am to 5:00pm. The cost is a minimum of \$5000 for 20 attendees and \$250 for each additional attendee up to 25 maximum. I am requesting approval to sign a training agreement to bring this valuable training to county leadership.

Authorize the purchase of "Drive the Road Leadership Course" and authorize HR Director Tracy Peters to sign a training agreement with PDL Connect Consulting, LLC, to bring in this one-day training in January 2025.
