# <u>Utility Permit</u> extension for Arvig Enterprises, Inc. to install fiber optic cables under Drains #32, #42 and Red River Tributaries in Sections 2, 14, 23, 25, 35 and 36 of Noble Township

Sean Fredricks indicated Arvig Enterprises, Inc. is requesting an extension of the *Utility Permit* to install fiber optic cables under Drains #32, #42 and Red River Tributaries in Sections 2, 14, 23, 25, 35 and 36 of Noble Township. The Board discussed granting an extension to December 31, 2025.
